2 If the child <b>did not</b> itemize deductions on Form 540 or Long Form 540NR, enter \$2,100. If the child itemized deductions, see instructions	2	00
3 Subtract line 2 from line 1. If zero or less, stop here; do not complete the rest of this form but <b>attach</b> it to the child's return	3	00
4 Enter the child's <b>taxable income</b> from Form 540, line 19 or <b>total taxable income</b> from Long Form 540NR, line 19	4	00
5 Net unearned income. Enter the <b>smaller</b> of line 3 or line 4. If zero or less, stop here; do not complete the rest of this form but <b>attach</b> it to the child's return	5	00

### Part II Tentative tax based on the tax rate of the parent listed above

6 Enter the parent's <b>taxable income</b> from Form 540, line 19; or <b>total taxable income</b> from Long or Short Form 540NR, line 19. If zero or less, enter -0-	6	00
7 Enter the total net unearned income, if any, from form(s) FTB 3800, line 5, of <b>all other</b> children of the parent identified above. <b>Do not</b> include the amount from line 5 above	7	00
8 Add line 5 through line 7	8	00
9 Enter the tax on the amount on line 8 based on the <b>parent's</b> filing status. Use the tax table or tax rate schedules found in the 2016 instructions for Form 540. See instructions for Long or Short Form 540NR filers	9	00
10 Enter the parent's tax from Form 540, line 31. See instructions for Long or Short Form 540NR filers. <b>Do not</b> include any tax from FTB 3803	10	00
11 Subtract line 10 from line 9. If you did not enter an amount on line 7, then enter the amount from line 11 on line 13 and skip line 12a and line 12b	11	00
12 a Add line 5 and line 7	12a	00
b Divide line 5 by line 12a. Enter the result as a decimal (rounded to four places)	12b X	
13 Multiply line 11 by the decimal amount on line 12b	13	00

### Part III Child's tax

If the amounts on line 4 and line 5 above are the same, enter -0- on line 15 and go to line 16.

14 Subtract line 5 from line 4	14	00
15 Enter the tax on the amount on line 14 based on the <b>child's</b> filing status. Use the tax table or tax rate schedules found in the 2016 instructions for Form 540. See instructions for Long Form 540NR filers	15	00
16 Add line 13 and line 15	16	00
17 Enter the tax on the amount on line 4 based on the <b>child's</b> filing status. Use the tax table or tax rate schedules found in the 2016 instructions for Form 540. See instructions for Long Form 540NR filers	17	00
18 Compare the amounts on line 16 and line 17. Enter the <b>larger</b> of the two amounts here and on the child's Form 540, line 31. Also check the box labeled "FTB 3800" on the child's tax return. See instructions for Long Form 540NR filers	18	00
