

No Cash Policy Exemption Request

We no longer accept cash payments. If we determine that paying in cash is necessary to avoid undue hardship, we may grant an exemption. Describe the nature of your business below and provide the reason you are unable to establish a bank account or pay by Web Pay at **ftb.ca.gov** or by cashier's check, personal check, credit card, or money order. We will notify you in writing when we approve or deny your request to pay in cash. Your payment must be for the exact amount. Change will not be provided. This Exemption Request must be renewed each year, no later than December 31st.

Penalties apply if you are required to make your tax payments by electronic funds transfer (EFT) and you pay by other means (California Revenue and Taxation Code 19011). This exemption will not relieve you from any penalties associated with your failure to pay electronically by EFT.
