Discuss the third draft of the proposed withholding regulations (Regulation Sections 18662-0 through 18662-6, 18662-8, and 19002).

Franchise Tax Board (FTB) staff also proposes to repeal the current text of Section 18662-7 and reserve the section for a future interested parties meeting to discuss the withholding rules to be applicable for domestic (U.S.) pass-through entities. This -7 portion of the regulations will be considered in a separate rulemaking project. In addition, FTB staff proposes to repeal Sections 18662-11 through 18662- 14.
